The Executive Director is the most visible embodiment of Five Rivers and is responsible for driving Five Rivers' pursuit of its mission, including the achievement of its financial and programmatic objectives based on Five Rivers' strategic plan.

The Executive Director's primary responsibilities include:

- Setting and meeting targets for organizational development, fundraising, membership cultivation, communications, and land conservation.
- Overseeing day-to-day operations and managing staff (currently 1.75 FTE).
- Ensuring sound financial management, including administration of all budgets and grants.
- Land acquisition and easement stewardship policy and oversight.
- Ensuring compliance with Land Trust Alliance accreditation requirements.
- Representing Five Rivers in the community.

# We seek an individual who will:

- Raise Five Rivers' profile in the region it serves and beyond.
- Expand our fundraising program so that we can increase our capacity to conserve land in the Five Rivers service area.
- Enlarge and diversify the membership and constituent base to reflect a broader range of individuals, including those traditionally underserved by conservation programs.
- Establish and build strong, cooperative partnerships with board members, community groups, financial contributors, easement donors, volunteers, and municipal officials.

- Exceptional interpersonal, verbal, and written communication skills, including public speaking.

<u>Position Details</u>: This is a 40-hour per week position with occasional evening or weekend activities – like leading a hike for members or hosting a nature trivia event at a local brewery. We anticipate that the ED may work remotely while coronavirus-related distancing guidelines are in place, but the long-term expectation is that the ED will primarily work from our Concord, NH office.
